Sub: Guidelines for Implementation of Amendment 1 to IS 15885(Part 2/Sec 13) : 2012 – Safety of Lamp Controlgear Part 2 Particular Requirements Section 13 d.c. or a.c. Supplied Electronic Controlgear for LED modules.

An Amendment No. 1 to IS 15885(Part 2/Sec 13):2012- Safety of dc or ac supplied electronic controlgear for LED modules has been established on 20.01.2016. The concurrent running of IS 15885(Part 2/Sec 13):2012 (without amendment no. 1) and IS 15885(Part 2/Sec 13):2012 (with amendment no. 1) is till 20.01.2017. The procedure for implementation of Amendment 1 to IS 15885(Part 2/Sec 13):2012 shall be as given below:

A. Application/Inclusion cases

- a) New applications and Inclusion Requests can now be submitted as per IS 15885(Part 2/Sec 13):2012 (with amendment no. 1)
- b) New applications and Inclusion Requests can also be submitted as per IS 15885(Part 2/Sec 13):2012 (without amendment no. 1). Such cases may be processed for grant of registration without considering Amendment 1, subject to the firm submitting a declaration in the form of undertaking, as per format given in Annex A, that test report showing compliance to IS 15885(Part 2/Sec 13) : 2012 (with amendment no. 1) shall be submitted by the applicant to BIS latest by 20 Jan 2017.
- c) New applications and Inclusion Requests shall not be recorded/received by BIS after 20.01.2017 onwards, if the test report does not indicate compliance to IS 15885(Part 2/Sec 13):2012 (with amendment no. 1).

B. Existing registered manufacturer's case

- a) Registered manufacturer shall submit any one base model for which registration is granted (out of all the base and series models registered till date) to BIS recognized Lab and get it tested for the applicable tests mentioned at Annex-I –Particular Additional Requirements for SELV dc or ac supplied electronic control gears for LED modules as per IS 15885(Part 2/Sec 13) : 2012 (with amendment no. 1). The said test report shall be submitted to BIS latest by 20 Jan 2017.
- b) In case, the registered manufacturer submits a test report for inclusion of a base model which complies to IS 15885(Part 2/Sec 13) : 2012 (with amendment no. 1) before 20 Jan 2017, and the inclusion is agreed to, it is not required to submit separate/additional sample for testing as mentioned at a) above. The registered manufacturer shall also submit an undertaking as per prescribed format (Annex A) that all models of the product (base and series models) manufactured after 20 Jan 2017 shall conform to IS 15885(Part 2/Sec 13):2012 (with amendment no. 1) and only

those found conforming to the same shall only be marked with standard mark mentioned in their letter for grant of registration/inclusion and no product/model without compliance of Amendment no. 1 shall be marked.

BIS shall give the acknowledgement of the receipt of test report as mentioned above. No separate letter would be issued by BIS in this regard. In case registered manufacturer fails to submit an undertaking and test report as mentioned above by 20 Jan 2017, a cancellation notice with 14 days time shall be issued and further actions including cancellation of registration shall be taken based on response of the manufacturer.

We also undertake that only those models of dc or ac supplied electronic controlgear for LED modules found conforming to IS 15885(Part 2/Sec 13) : 2012 (with amendment no. 1) shall be marked with Standard Mark after Registration. In case the models registered are found not conforming to IS 15885(Part 2/Sec 13):2012 (with amendment no. 1), then BIS may take any action under the Rules/Order in this regard.
