Subject: Implementation of IS 16333 (Part 3) for Mobile Phones

As per MeitY's order dated 17.01.2018, the last date of implementation of Indian Language Support for Mobile Phone Handsets as per IS 16333 (Part 3) : 2016 was 23 02 2018. The last date has thereafter been extended by Ministry of Electronics & Information Technology (MeitY) upto 01 05 2018 in order to facilitate the industry for smooth implementation of CRO.

Provision to apply for compliance to IS 16333 (Part 3) for existing registered manufacturer for Mobile Phones has already been re-enabled and will be available upto 01 05 2018. The test report(s) along with undertaking(s) should be submitted to BIS for processing accordingly. In case the registered manufacturer do not apply for implementation of IS 16333 (Part 3) till the stipulated date, it would be presumed that they are no longer interested in continuing the said registration and as such the registration will be cancelled without any further reference.

New application(s)/inclusion(s) for Mobile Phones only as per IS 13252 (Part 1) will be processed for grant by BIS subject to submission of undertaking that registered manufacturer will ensure to implement the guidelines for implementation of IS 16333 (Part 3) on or before 01.05.2018, failing which it would be presumed that they are no longer interested in continuing the said registration/application and as such the registration will be cancelled/application will be rejected without any further reference.. The Format for undertaking is enclosed at Annex – 1.

New application(s)/inclusion(s) for Mobile Phones accompanied by test reports as per IS 13252 (Part 1) as well as IS 16333 (Part 3) will continue to be accepted by BIS.

Registered manufacturers submitting new inclusion requests for Mobile Phones wherein the software solution/utility for implementation of Indian Language Support for Mobile Phones as per IS 16333 (Part 3) is same as that of previously registered model will also require to submit a test report to establish implementation of Indian Language Support for Mobile Phones as per IS 16333 (Part 3).

All other procedures for the implementation of Indian Language Support for Mobile Phone as per IS 16333 (Part 3) remain the same as per the earlier guidelines Ref: CMD III/16: IS 16333 (Part 3) dated 13-06-2017 and CMD III/16: IS 16333 (Part 3) dated 04-08-2017.
