Subject: Online module for changeover from IS 16046 : 2015/IEC 62133 : 2012 to IS 16046 (Part 1) : 2018/IEC 62133-1 : 2017 and IS 16046 (Part 2) : 2018/IEC 62133-2 : 2017 as per option A.

1. This has reference to CMD-III's guidelines **Ref: CMD-III/16: IS 16046** dated 11 March 2019 with the subject '[Guidelines for Implementation of Revised Standards IS 16046 \(Part 1\): 2018/IEC 62133-1: 2017 and IS 16046 \(Part 2\): 2018/ IEC 62133-2: 2017 superseding IS 16046:2015/ IEC 62133: 2012 - Secondary cells and batteries containing alkaline or other non-acid electrolytes](#)'.
2. Provision of applying online for revision of IS 16046 : 2015/ IEC 62133 : 2012 as per Option B of the above mentioned guidelines is already in place since April 2019.
3. Provision of applying online for revision of IS 16046 : 2015/ IEC 62133 : 2012 as per Option A of the above mentioned guidelines has been made live on CRS website. [FAQ for the changeover](#) have been hosted on CRS website on 21 June 2019.
4. The following online procedure is to be followed if registered manufacturers wish to apply for changeover using option A:
 - a. Use your existing login credentials for login on CRS website.
 - b. On your dashboard, click on the tab 'Submitted Application(s)'.
 - c. On the page of submitted applications, kindly locate your existing registration as per IS 16046 : 2015/ IEC 62133 : 2012.
 - d. Below the existing CRS no., click on the link '**Apply for revision of IS 16046**'.

(NOTE: Please do not apply using this option if you have already applied/intend to apply under Option B).

- e. On clicking, Form I will open. Based on the data entered in your existing application, information on the Form I has been partially, populated.
- f. Select appropriate IS no. from the dropdown, i.e. IS 16046 (Part 1) : 2018/IEC 62133-1: 2017 or IS 16046 (Part 2) : 2018/ IEC 62133-2: 2017 under which you wish to apply.

(NOTE: Nickel system cells and batteries are covered under IS 16046 (Part 1) : 2018/ IEC 62133-1 : 2017. Lithium system cells and batteries are covered under IS 16046 (Part 2) : 2018/ IEC 62133-2 : 2017.)

- g. The supplementary Test Report(s) for changeover of the Indian Standard to be uploaded. Kindly edit/fill the other details.
 - h. Make payment to submit the application online. Documents as per Clause 6 (vi) of the [guidelines issued by CMD-III](#) to be submitted to BIS.
 - i. On grant of new R-number, inclusion of new models and revision of existing models can be done through inclusion module in new R-number.
 - j. After changeover as per Option A, if you wish to apply for changeover to revised standard for your other models registered as per IS 16046 : 2015/ IEC 62133 : 2012, kindly proceed to 'Inclusion' option. Kindly select the IS number, then select the option for uploading supplementary Test Report on the inclusion page and proceed. No fee is required for uploading supplementary report for this option.
 - k. As per the guidelines, supplementary Test Report can be accepted under Option A. In case of availability of complete Test Report, the request may be submitted under 'Inclusion' with applicable fee.
