Subject: Extension in the date of Implementation of revised IS 616:2017/IEC 60065:2014 superseding IS 616:2010/IEC 60065:2005 – Audio, Video and similar Electronic Apparatus – Safety Requirements

IS 616:2010/IEC 60065:2005 has been revised as IS 616:2017/IEC 60065:2014 and both the versions are under concurrent running upto 27.06.2018.BIS Guidelines for implementation of IS 616:2017/IEC 60065:2014 have been issued vide our circular reference no.CMD-III:16/IS 616 dated 13.09.2017.

Competent Authority of BIS has agreed for the extension of the concurrent running period of the standards to 31.12.2018 and hence the last date of implementation of IS 616:2017/IEC 60065:2014 is 31.12.2018, with no change in the BIS Guidelines.

All new applicants applying as per IS 616:2010/IEC 60065:2005 shall give an undertaking (Format at Annex 1) that they shall switchover to IS 616:2017/IEC 60065:2014 before 31.12. 2018.

All existing registered manufacturers are required to apply online for changeover before 31.12.2018. They shall also submit an undertaking (Format at Annex 2) that all models of the product (base and series models) conform to IS 616:2017/IEC 60065:2014 and only those models found conforming to the revised standard shall be marked with the Standard Mark to IS 616:2017/IEC 60065:2014 along with Registration number and that models as per old version of Standard shall not be marked .after 31.12.2018.

All other procedures for the changeover remain the same as per the earlier guidelines reference no.; CMD-III:16/IS 616 dated 13.09.2017.
